## Membership-Dues

To cover the costs of a very lean organization in London, essentially one full-time employee and routine telephone, fax and other office expenses, the Executive Council of the ILA, our parent organization, approved an increase in dues from £20 (about \$34) per Branch member to £25 (about \$42) per Branch member effective 1 January 1998. The American Branch (ABILA) Executive Committee felt that it had no option but to reflect this increase by increasing dues for membership in the Branch by \$10 per year. Thus, effective 1 January 1998, annual dues for membership in the ABILA will be \$60 instead of \$50 per annum. The remainder after payment to the parent organization (about \$16 per member) goes to pay printing and distribution costs for the Newsletters, our biennial Proceedings, the accounting firm whose annual reports are necessary to maintain our tax-free status and similar unavoidable expenses. We have no paid support staff and members of the Executive Committee pay all their own expenses.

At its meeting in Washington, DC, on 11 April 1997, the ABILA Executive Committee adopted an amendment to the By-Laws of the Branch to reflect this change. At the same time, the Executive Committee decided to replace the "Special Student" membership category with a non-membership "Student Associate" category for which no dues would be charged. Students wishing full membership may still join the ABILA and ILA as Regular Members by paying full dues, but

students not wanting membership in our parent organization would still receive the ABILA publications and be eligible for associate status in ABILA Committees. They would not be members of the ILA nor be eligible via the Branch for appointment to ILA Committees.

Thus, effective 1 January 1998, Article IV of the ABILA By-Laws is amended to show membership categories as follows:

Regular Individual:	\$ 60
Sustaining Individual:	\$ 100
Institutional:	\$ 80

Needless to say, the members of the Executive Committee, all of whom pay regular or sustaining individual dues, deeply regret the necessity for this increase. But we are satisfied that there is no further "fat" in London or in the United States to be cut. In addition to eliminating any dues for Student Associates, we continue to keep International Law Weekend available to all without registration fee, and are able to maintain our full range of publications mailed to Branch members and associates at no additional cost.

The financial stringency in London has forced us also to update our mailing lists. **This will be the last Newsletter that can be sent to persons or institutions who are not current members or associates of the ABILA.**

A membership form at the current (1997) rate is enclosed. Forms for 1998 membership will be distributed with the first Newsletter for 1998.

Noyes, Director of the International Legal Studies Program at California Western School of Law, undertook the record-keeping and Ms. Elizabeth Johnson has been doing extraordinary work creating the necessary lists. The overall arrangement is not the best, but we depend entirely on volunteers and are extremely lucky to have been able to find them. We are very grateful to Mr. Shapiro, Professor Noyes and Ms. Johnson.

## International Practitioner's Notebook

The International Law Students Association (ILSA) published and distributed International Practitioners Notebook just before International Law Weekend 1996. Nova Southeastern University Law School did the essential work under the direction of J. Craig Garrett, the editor of the ILSA Journal. The substantive papers are a selection of the papers presented at International Law Weekend 1995.

Arrangements have been made for the ILSA Journal of International and Comparative Law to continue to publish and distribute our International Practitioner's Notebook, with papers

culled from International Law Weekend. Those who attended International Law Weekend 1996 will especially appreciate the work done in editing and publishing these papers.

## American Branch Proceedings

The biennial Proceedings of the American Branch of the International Law Association are being compiled, as usual. The Editor is again Professor John E. Noyes, Director of the International Legal Studies Program at California Western School of Law in San Diego. Aside from Branch Committee Reports and other usual documents, the Proceedings for 1997-1998 will contain copies of the formal dinner and luncheon speeches given at International Law Weekend if the speakers make them available to us. By a quirk in our tradition, the available speeches for 1994 and 1995 appear in the 1995-96 Proceedings, and the speeches by the Hon. Edward McWhinney, Q.C., M.P., the Canadian Parliamentary Secretary (Fisheries and Oceans) and Judge Charles N. Brower, President of the American Society of International Law, both given at International Law Weekend 1996, will appear in the 1997-98 Proceedings along with the speeches to be given at International Law Weekend 1997.

## ILA Biennial Conference

The 1998 biennial ILA meeting will take place in Taipei on 24-30 May 1998. The Taiwan Branch will be host. By our Constitution, Branches of the Association are regional, and not necessarily national. Therefore, the Conference in Taiwan does not imply any position with regard to the future governance or territorial integrity of China.

(It is cheaper to join the Branch and pay the members' fee than to register as a non-member.) Chairs and Rapporteurs of ILA Committees can register for only \$200. After 31 March 1998, the registration fee goes up by \$100 for members, their ac-

accompanying persons and non-members. The fees for all others increase by \$50 each.

The British Branch will be host for the jubilee year 2000. Tentative planning has begun around the starting date of 13 August, 2000.

## Other Branch Conferences

Three Branches of the ILA are currently planning Branch Conferences to which all members of the American Branch are welcome.

As reported in the last Newsletter, there will be a Regional Meeting of the ILA in Moscow on 17-20 September 1997. Registration begins at 9 AM on Wednesday, 17 September, at the Press Centre, Ministry for Foreign Affairs of the Russian Federation, Zubovsky Boulevard 4, Moscow. The registration fee is US\$200 each for members and their accompanying persons, \$100 each for members under 30 and their accompanying persons, and \$300 each for non-members and their accompanying persons. Since membership costs less than \$100, it is desirable to join a Branch before registering. Accommodations at very reasonable rates are available at the Moskva, Rossia and Peking Hotels; rather less luxurious accommodations are available at the Metropol, Savoy and National Hotels. Those interested should contact Professor Anatoly Kolodkin, President of the Russian Association of International Law, which is also the Russian Branch of the ILA. He can be reached by Fax at 7-095-152-09-16, 7-502-224-17-01 or 7-502-241-11-66. He will need to know details of your arrival, hotel reservations required or booked, return address

and passport data for visas, and the name of the Russian Embassy or Consulate where a visa will be sought.

The Indian Branch has announced a Conference on International Trade Law 2-5 January 1998 in New Delhi and Bombay. The ILA Committee on International Civil and Commercial Litigation will meet in New Delhi on Friday and Saturday Morning, 2-3 January, and the Conference proper will begin there Saturday evening. Sessions will be held on Sunday, 4 January, focusing on the Hague and Vienna Conventions, UNIDROIT principles, problems of parallel international litigation (including *forum non conveniens* and Bhopal) and the extraterritorial application of national standards (including Helms-Burton). On Monday morning, the Conference will fly to Bombay and resume that afternoon. It will end with a dinner in Bombay Monday evening, 5 January. Members of the American Branch expected to participate include Peter Trooboff, Esq., and Professor Friedrich K. Juenger.

## ILA Committees

The ILA Executive Council met in London on 26 April 1997.

The new arrangement whereby chairs of ILA committees may nominate up to five persons to membership in their committees regardless of Branch affiliation has taken effect. Each such nomination needs the approval of the Director of Studies. The new procedure does not limit the existing authority of each Branch to nominate members to places in ILA committees subject to the approval of the chair of the committee, but provides the chairs with an additional source of expertise in case more than one or two members of any particular branch have expertise believed important to the work of the ILA committee. Nor does the new procedure limit the existing arrangement

whereby chairs and reporters' positions can be filled by the Director of Studies without regard to Branch memberships.

Under this new authority, and after consultation with the Branch, the Chairman of the ILA Committee on International Trade Law nominated Professor William J. Davey of the University of Illinois, currently chief legal officer of the World Trade Organization, to membership. Since Professor Davey is not a member of the Branch, it was decided that his membership in the Committee would best be achieved by his joining the Headquarters Branch as an International Organization employee.

Branch nominations: All ABILA nominations to international committees were approved and the current ILA committee memberships are noted in the list attached to this Newsletter. Here are some of the more significant details:

Professor Alan Swan, chairman of the parallel American Branch committee was accepted as the third American Branch member of the International Trade Law Committee. The usual rule of one member and one alternate from any one Branch has been relaxed for this Committee in view of the expertise and interest of members of the American Branch.

John B. Rhinelander, Esq., replaced Professor Phillip Trimble as the American member of the ILA Committee on Arms Control and Disarmament. The Alternate member is Ambassador Thomas Graham. Mary Elizabeth Hoinkes has taken the chair of the parallel American Branch Committee on Arms Control and Disarmament. Members of the Branch who are interested in joining the ABILA committee should contact her directly.

A new ILA Committee on Diplomatic Protection of Persons and Property has been formed under the Chairmanship of Professor Richard B. Bilder. At Professor Bilder's request, the American Branch nominated Professor David Caron to membership in the Committee and Professor David Bederman to be an alternate member. Professor Bederman will also serve as chairman of the parallel ABILA committee. Those interested in joining that parallel Branch committee to review the work of the Reporters of the ILA committee and perhaps write Reports of their own on the subject should contact Professor Bederman directly.

Professor Daniel Bodansky has resigned as the American Branch member of the Committee on Coastal State Jurisdiction over Marine Pollution. Professor John E. Noyes replaces him.

A new ILA Committee on the Accountability of International Organizations has been formed under the Chairmanship of Judge P.H. Kooijmans (Netherlands). Paul Szasz, Esq., will be the ABILA member of the Committee.

Other notable changes involving American Branch members' participation in international committees include the appointment of Professor Joseph Dellapenna to be Reporter for the Committee on Water Resources Law and the resignation of Professor Gail McK. Beckman from co-Reportership in the Committee on Intercountry Adoption and Protection of Children. That Committee is currently being restructured.

## ILA Committee Membership Policy

Membership in international committees is based on individual reputation and achievement and does not represent any Branch orthodoxy. Nominations to international committees are normally reserved to members of the Branch who have achieved a reputation sufficient to support the nomination. Active work as Reporter or Chair of a Branch committee is frequently the most persuasive criterion to establish a reputation adequate to support nomination to an international committee.

Several international committees do not have American Branch members or alternates. The easiest way to be nominated to membership in an international committee is to serve as an organizer/chairman or reporter of an American Branch committee dealing with a related subject.

If there is no international committee currently dealing with a significant topic of sufficient interest, the easiest way to form one is to organize an American Branch committee on that topic, produce a report that can be circulated to the general membership and our counterparts in the parent organization, and then propose an international committee. The successful proposer of an international committee is usually asked to be its organizer, chair or reporter. The process is not difficult.

There is constant turnover in membership of both American Branch and ILA committees. Those members of the Branch interested in participating more actively in the committee work of the organization at any level should contact the chairs of existing committees or the Director of Studies directly.

## American Branch Committee Activities

Branch committee chairs are always looking for reporters and members who want to be active. A current listing of Branch committees and their chairs and reporters is appended to this Newsletter.
