International Law Weekend 1987 November 6 and November 7 - Program Below

#### LETTER FROM THE NEW PRESIDENT OF THE AMERICAN BRANCH

"This is my first opportunity as President of the American Branch to communicate with those of you who have have joined the International Law Association through our Branch. For the longtime members of the Branch, I only wish to tell you how pleased I am to be able to try to follow in the footsteps of John Hazard and Robert von Mehren and I hope that the Branch under my leadership will live up to the standards set by them. As for newer members, I have a sense that there may not be a full understanding of how the Branch goes about doing its work and what membership in the Branch means. I hope therefore to use this opportunity to give you my impression of our Branch work.

In the last fifteen years since the late Professor Alona Evans of Wellesley College instituted the tradition of International Law Weekend, the Branch as chief sponsor of that Weekend has become much more visible. Adding to our new visibility is the publication of International Practitioner's Notebook, originated by Professor Edward Gordon, who is now our Chairperson of the Committee on Committees. This visibility, which may have attracted some of you to membership, does not, however, tell you how the American Branch participates in the progressive development of international law. Also, the relationship of the Branch to the ILA itself headquartered in London and the ILA's own work may be unclear. For more clarity, I recommend to you the brief summary in our Proceedings and Committee Reports of 1985-86 on page 1, The Functions of the International Law Association". That summary gives a little of our history and the history of the ILA itself and explains the centerpiece of the ILA work, the biennial Conferences of the ILA held in different countries. All members of all branches are invited and encouraged to attend the Conferences: the next Conference in August 1988 is to be held in Warsaw, Poland.

In addition to the biennial Conferences, the branches coordinate their work and keep in touch with the work of the ILA and its international committees by electing delegates to the Executive Council of the ILA which traditionally meets at the Headquarters in London in October and May. As many of you may know, the Chairman of the Executive Council and thus the Head of the International Law Association is our own Cecil Olmstead. At present, the "delegates" to the Executive Council meetings from the American Branch

are myself, Robert von Mehren, Chairman of our American Branch Executive Committee, and Professor Richard Lillich. In the absence of or the inability of any one of these three to attend an Executive Council session, I shall ask another member if he or she would be able to attend to represent the Branch. It is at the Executive Council meetings that the planning for the biennial Conferences takes place and, above all, reports are made by the ILA's Director of Studies, currently Professor Ian Brownlie, QC, on the progress of the work of the international committies.

While it is not at all difficult to work with the American Branch by indicating your interest in one of our American Branch Committees, membership in an international committee is by invitation only and therefore a mark of the scholarly expertise of the individual concerned in the particular topic to be considered by the international committee. Since, in general, the international committees attempt to allocate their membership over the nationalities of the more than forty branches of the Association, usually there are no more than one or two Americans on any international law committee. However, to the extent that our Branch committees are organized to parallel the work of the international committees, valuable work and insights may be funnelled to an international committee. One of our younger members, and a relatively new member of our Executive Committee, Professor Mark Janis of the University of Connecticut School of Law, is particularly interested in encouraging and assisting younger members of our Branch and/or students of international law to participate in the work of the committees, both of our Branch and of the ILA itself. He suggests that for any of you who are also professors and would like to involve your more interested students, you write him to coordinate with him on involvement in the work of the ILA.

It is my hope as President that we can encourage this sort of participation and involvement. As the summary on the functions of the International Law Association that appears in our 1985-86 Proceedings states: "[Our] reports represent no official United States view but rather the divergent views of committee members". There is thus not only opportunity for work, but also an assurance that an individual perspective on contemporary problems in international law will be given its day. I hope that all of you who wish to become more involved in the work of the Association will write to Professor Janis, Professor Gordon or myself with your proposals and interests.

#### INTERNATIONAL LAW WEEKEND

An excellent weekend is scheduled. Panel discussions are planned for Friday morning and Friday afternoon and Saturday morning and possibly Saturday afternoon.

The American Branch is privileged to have as its speaker at the dinner Friday night the Chairman of the Executive Council of the International Law Association, Cecil J. Olmstead, and to have present at the Friday night dinner, Professor Jerzy Makarczyk, President, Polish Branch of the ILA, who will discuss the 1988 Conference to be held in Warsaw. Also, the American Branch is pleased to have as its speaker at the luncheon Saturday afternoon, Steven J. Stein, Chairperson of the Committee on the International Law, The Association of the Bar of the City of New York. All events will be held at The House of the Association of the City of New York, except for the Friday night dinner on November 6 which will be held at The Princeton Club of New York. Mr. Frederick Tipson, Ms. Jan Schneider and Professor Michael Glennon have organized the programfor the Weekend.

Details of International Law Weekend are set forth below. Please note that no reservations for the annual dinner on Friday night will be accepted after 10:00 a.m. on Wednesday, November 4, and no reservations for

the Saturday lunch will be accepted after 10:00 a.m. on Thursday, November 5, or at such earlier time when all places are taken. Because the American Branch has incurred large deficits in the past for persons reserving places for dinner or lunch and then not attending, payment for the Friday night dinner and Saturday lunch must be received in advance at least two days prior to the respective event or reservations will be automatically cancelled. A registration and reservation form is enclosed herewith for your convenience.

#### 63RD CONFERENCE OF THE ILA TO BE HELD IN WARSAW, POLAND

The 63rd Conference of the International Law Association is scheduled to take place on August 21 through 28, 1988, in Warsaw, Poland. The Intercontinental Victoria Hotel will serve as the Conference Center. Brochures have been mailed to each member requesting initial interest in attending the Conference. A US \$300 conference fee for participants has been proposed.

#### ILA EXECUTIVE COUNCIL MEETINGS

The Executive Council of the ILA met on November 15, 1986 and on May 2, 1987.

At the November 1986 Executive Council meeting, at which Professors Lichtenstein and Lillich and Mr. Von Mehren attended for the American Branch, the Council devoted substantial attention to reviewing and confirming the results of the Seoul Conference and to reviewing initial plans for the Warsaw Conference in 1988.

At the May 1987 Executive Council meeting, Professors Lichtenstein and Lillich attended for the American Branch. The Council considered in depth matters relating to the International Committees and the Director of Studies' Report. Professor Brownlie reviewed the work of the International Committees and asked for the advice of the Council with respect to certain issues. Specific matters were discussed on aspects relating to the following Committees: "International Recognition of Adoption," "Legal Problems of Divided States," "State Immunity," "New International Economic Order," "Legal Aspects of Extra-Territorial Jurisdiction," "Securities Regulations (Harmonization and Extra-Territorial Effects"), "Water Resources," "Exclusive Economic Zone," "The Right to Food," and "International Committee on Arbitration."

The Council also reported that the Egyptian Branch of the ILA had been reactivated.

In addition, the Council discussed the possibility of having the 64th Conference of the ILA in Australia in 1990, and this matter would be pursued further with the Australian Branch.

#### JUDGE JOHN EDWARDS

We announce with great regret the death of Judge John Edwards on July 9. Mr. Edwards was the Honorary Secretary-General of the ILA for many years.

#### CHANGES IN OFFICERS OF THE ILA
