Plans are well advanced for the biennial Conference of the International Law Association, to be held in Helsinki on 11-17 August 1996. Although the deadline for early registration has passed (it was I May), at the Executive Council meeting in London on 4 May the Finnish organizers agreed to continue for another month the US\$400 registration fee

for members of the Association! Late registrants will be charged US\$500. Spouses and other accompanying persons who expect to participate in the program must also register at the same cost; thus the cost for a husband/wife couple is still US\$800. The registration fee for non-members of the Association is US\$700. The registration fee for ILA members under 30 years is US\$250. Since membership in the American Branch, which carries with it membership in the Association, is only \$50, it is obviously cheaper to join the Branch and then register as an Association member than it is to register as an outsider.

Briefing at US Embassy

A briefing for members of the American Branch and their spouses is tentatively scheduled at the American Embassy in Helsinki for the "Embassy evening," Tuesday, 13 August. The subject will be Finland's evolving policy towards Russia, Scandinavia and the US.

All hotel reservations should be made through the Finnish organizers. They have negotiated extraordinarily favorable hotel rates that will not be available to people seeking to make their own reservations. Those planning pre- or post-Conference tours sponsored by the Finnish organizers can take advantage of those rates also, if they will make their bookings through the Finnish Branch.

Getting There from Here

The official travel agent for members of the American Branch traveling to Helsinki is Fresh Pond Travel, 186 Alewife Brook Pkwy, Cambridge, MA 02138. They can be contacted via a live receptionist at (617) 661-9200 or (800) 645-0001. In either case, they will be referred to the "Tufts Diamond Team." The Diamond Team can also be reached directly on (617) 661-6674, but the call might be placed on hold there until an agent is free. A prompt call-back is promised if the caller leaves a voice-mail message with a telephone number. Callers should identify themselves as attending the Helsinki Conference in association with the Tufts International Law Association.

As a result of some concerns expressed by members, our treasurer met with FinnAir directly and requested a special concessional fare for American Branch members traveling to the Biennial Conference in Helsinki. Finn Air agreed to offer a special rate of \$730 plus taxes from New York or \$930 from San Francisco to American Branch members on midweek flights with a one week layover. (Finn Air has subsequently indicated that it will make this fare available for weekend flights as well and that it will waive the week layover requirement for ILA members). Finn Air has also agreed to offer a sepcial reduced business class fare on these flights. These rates are being offered through a travel agent designated by Finn Air:

Members must identify themselves as ILA members traveling to the Helsinki biennial conference to secure these rates. Both the New York and San Francisco flights are non-stop to Helsinki; the San Francisco flight takes a Polar route which reaches Helsinki in under 10 hours—cutting 4-6 hours off the flying time of eastbound connections.



Members interested in availing themselves of these rates should act quickly, since only a limited number of seats are available. We are also advised that the first two weeks of August is the peak vacation season in Finland, so inbound flights and hotels are likely to be filled soon.

1996 Membership Drive Now Underway

As we go to press, the American Branch has 367 members, including over one hundred new members, most of whom have joined us as a result of our joint membership drive with the American Society of International Law. However, nearly 150 members who were current in 1995 have yet to renew. If this Newsletter arrived in your mailer with a membership renewal notice, then our records show that you are not current. Please take the time to fill out the form and return it.

John Hazard Remembered

On 6 May the American Branch of the ILA joined with the American Foreign Law Association, the Harriman Institute of Columba University and the Association of the Bar of the City of New York's Committee on the CIS in sponsoring the Second John N. Hazard Lecture at the City Bar. Ruth Wedgwood spoke on behalf of the ILA at the event, which was chaired by Scott Horton and included remarks by the AFLA's Richard Lutringer and Harriman director Mark von Hagen, among others. The event attracted a standing-room only crowd. The lecture was delivered by Leon Lipson, Henry R. Luce Professor of Jurisprudence Emeritus at Yale University. Consistent with the theme for the lecture series, Prof. Lipson's presentation was entitled "Russia and the Rule of Law: Whose Rule? Which Russia? What Law?"

The Third John N. Hazard Lecture is scheduled for the spring of 1997 and is expected to feature Prof. Peter Maggs of the University of Illinois School of Law. Those interested in attending can contact Scott Horton for details at (212) 336-2820.

Other Meetings of the ILA and its Branches

The planning for the 1998 biennial ILA meeting has already begun. The host will be the Taiwan Branch. The dates have been provisionally fixed for 24-30 May 1998.

The British Branch will be host for the jubilee year 2000. Tentative planning has begun around the starting date of 13 August 2000.

Other News from the ILA

The Executive Council of the ILA met in London on 3-4 May 1996. It was decided to hold at the Helsinki meeting a workshop on the future of the ILA. This is likely to include a major review of the committee structure and work of the organization.

The Executive Council also elected Professor A.H.A. Soons, the President of the Netherlands Branch, to succeed Professor James Crawford as Director of Studies. Professor Crawford's term expires after the Helsinki Report is produced.

There was a serious discussion about membership and dues. A proposal to raise the annual Branch contribution to the expenses of Headquarters by £10 per Branch member (the current contribution is £20; the proposal was to raise it to £30) was rejected. Recognizing that there has been no increase since 1988, expenses have risen somewhat, and membership is more or less stable, the need for some raise was acknowledged. It was decided to recommend that Branch contributions be raised to £25 per Branch member. If the current proposal is adopted as expected at Helsinki, it might be necessary to raise the annual dues of the American Branch from the current \$50, but that is a matter to be discussed after the final decisions are made at Helsinki. Currently, about \$32 of your \$50 dues goes to Headquarters; the rest goes to expenses of producing and distributing our publications.

The increase, if approved by the Executive Council in the usual way, would not go into effect until 1 January 1998. Whether that increase would have to be reflected in an increase in Branch dues would have to be evaluated by the Branch Executive Committee before the dues notices

for 1998 are sent out. There seems to be ample time left for sober reflection.

Changes in the Association's Constitution were discussed. Most of the suggestions of the American Branch regarding that Constitution were accepted, but final decisions will be made only after the Helsinki Conference.


Branch Committee Activities

Executive Committee

The Executive Committee of the Branch met in Washington on 29 March. It reviewed changes proposed in the organization's Constitution in light of recommendations made by a subcommittee headed by Robert B. von Mehren assisted by Cynthia Lichtenstein and Scott Horton. The principal change is to recommend that nominations to positions in the organization be made according to regulations to be approved by the Executive Council rather than be made by the Chairman of the Executive Council directly.

The Executive Director of ILSA, David Sabin Anderson, affirmed the arrangements by which International Practitioners Notebook is being produced. Mark Zaid, Esq., also attended as a guest of the Executive Committee.

Professor Michael P. Scharf, the Program Committee Chairman for International Law Weekend 1996 presented a Report indicating the great progress which has been made in organizing that annual event, scheduled for 31 October - 2 November 1996. The major overall theme for the Weekend is "Rights and Obligations of Persons



under International Law." Many panels focus on human rights in various guises. Some, such as recent developments in Mutual Legal Assistance, extraterritorial law enforcement, and the Foreign Corrupt Practices Act, reflect items of particular interest to our many practitioner members. Other panels are still in the course of organization, and members interested in participating still have time to get in touch with Professor Scharf or the members of his Program Committee. The Executive Committee was informed that our Hon. Treasurer, Scott Horton, Esq., has resigned that vital post in order to assume the presidency of the International League for Human Rights, the world's oldest international human rights organization. Their gain is our loss; Scott's service to the American Branch of the International Law Association has been as near to irreplaceable as can be. An active search for a new Hon. Treasurer is underway. The Executive Committee let Scott know how much his work has been appreciated and our hope that he will continue as a member of that Committee.

On 16 April 1996 it was formally announced that Professor David Leebron, a member of our Executive Committee, had been selected to become Dean of the Columbia University School of Law.

American Branch Committees

The Director of Studies, Charles D. Siegal, reported to the Executive Committee on the activities of the Committees of the Branch.

The Committee on An International Criminal Court is being organized by Professor Leila Sadat Wexler of Washington University in St. Louis. A planning session was held during the annual meeting of the American Society of International Law. Mr. Robinson is now also the American Branch's member in the International Committee on the same topic. It is envisaged that the Reporter for the Branch Committee, if all goes well, would be nominated to be the Alternate Branch member in the International Committee. If the International Committee cannot produce a worthy Report within a reasonable time, and the American Branch Committee can produce an initiative for international attention, we are prepared to propose that the work of the American Branch Committee be considered a basis for the further work of the International Committee.

International Committees

In addition to the appointment of Davis Robinson to the Committee on the Formation of a Rule of Customary International Law and Ernest T. Patrikis to the International Monetary Law Committee as noted above, Barbara J. Green has been nominated to be the Alternate Branch member of the Committee on Securities Regulation. Hurst Hannum has resigned as Reporter of the Committee on Human Rights Law and Practice, and has been approved as alternate Branch member of that committee.

Several international committees do not have American Branch members or alternates. The easiest way to be nominated to membership in an international committee is to serve as an organizer/chairman or reporter of an American Branch committee dealing with a related subject.

If there is no international committee currently dealing with a significant topic of sufficient interest, the easiest way to form one is to organize an American Branch committee on that topic, produce a report that can be circulated to the general membership and our counterparts in the parent organization, and then propose an international committee. The successful proposer of an international committee is usually asked to be its organizer, chair or reporter. The process is not difficult. But

neither the Branch nor our parent Association is interested in conferring empty titles; there is too much exciting work to be done, and our function is to serve as the organization through which those interested in doing it can be adequately recognized.

A full list of international committees and their American Branch members and alternates is included in this Newsletter.

Committees Policy

Any member wishing to organize a new Branch committee on any topic within the purview of the ILA should contact the Director of Studies proposing a topic, a Reporter, and a plan for the recruitment of qualified members. The proposer may also take the chair and serve as Reporter for a new committee if a membership of the committee that is large enough and diverse enough can be achieved.

Since membership in international committees is based on individual reputation and achievement and does not represent any Branch orthodoxy, nominations to international committees are normally reserved to members of the Branch who have established a reputation sufficient to support the nomination. Active work as Reporter or Chair of a Branch committee is frequently the most persuasive criterion; a good way to establish a reputation adequate to support the nomination to an international committee.




