### Dues for 1998

The new assessment schedule has gone into effect. As announced in prior Newsletters, due to increased costs at our Headquarters in London since the last schedule of assessments was agreed, it was felt necessary to raise the annual assessment from £20 per member to £25 per member. As reflected in exchange rates and our need for funds to pay for minimal help in maintaining our records and accounting services, the production and mailing of Newsletters about three times each year, our share of the costs of INTERNATIONAL PRACTITIONER'S NOTEBOOK (now being produced by arrangement with the International Law Students Association and Nova University School of Law) and our biennial Proceedings, it was felt necessary to raise our dues for Regular Members from \$50 to \$60 per annum, and Institutional members from \$70 to \$80 per annum. Dues for Sustaining Members remain unchanged at \$100. For students currently enrolled in a full-time university program. we offer the opportunity to become associates of ABILA at no charge, without the right to be eligible to serve as members of international committees or to receive headquarters publications. Obviously, the budget is extremely tight, and if anybody can find any fat to cut, his or her advice would be very welcome.

This Newsletter is being sent to all 1997 members. Further 1998 publications of the ABILA will be sent only to persons who have paid their dues for 1998 by May 30, 1998.

The award was a book of essays edited by Professors Jonathan I. Charney, Mary Ellen O'Con-

nell and Donald K. Anton. Professor Henkin titled his address at the gala dinner: Law and the Millennium: Faith, Hope and Schizophrenia.

### Other Activities of the ABILA

The Executive Committee of the American Branch met on 8 November 1997, during International Law Weekend. The major items were:

- 1. Review of the proposed new ILA Constitution and committee Regulations;
- 2. Review of the record-keeping and expenses of the Branch;
- 3. Review of the publications and other activities of the Branch.

It was agreed that the system of voluntary record-keeping is barely adequate; the pro bono efforts of the major law firms and universities interested in our work are no longer adequate to the burdens of membership dues and address-keeping. If you consider the amount of our dues we must render to Headquarters (which is a very minimal operation, dependent largely on voluntary contributions of time and space there, but with some overhead to pay and publications to produce and distribute), plus the cost of producing and distributing our own publications, it is clear that our dues are the absolute minimum necessary to keep us afloat. Indeed, without the small income from our small endowment, occasional and very welcome gifts, the generosity of the co-sponsors of International Law Weekend, the arrangements with Nova Southeastern University with regard to International Practitioner's Notebook, and the voluntary help of many of our members and officials, operations at the current level would be impossible. Be warned: Anybody who complains about our inefficiencies will be asked to shoulder the organizational responsibilities that are the subject of complaint!

James E. Beggans, Esq., undertook to chair a committee to prepare a web-site for the Branch.

The Nominating Committee of the ABILA is being reconstituted. After many years of distinguished and time-consuming service, Professor Valerie Epps has stepped aside and Professor John F. Murphy, a Vice-President of the Branch, has accepted the Chair.

## International Law Association Biennial Conference

The 1998 biennial ILA meeting will take place in Taipei 24-30 May 1998. The Taiwan Branch will be host. By our Constitution, Branches of the Association are regional, and not necessarily national. Therefore, the Conference in Taiwan does

not imply any position with regard to the future governance or territorial integrity of China.

# ILA Executive Council Meeting

The ILA Executive Council met in London on 21 November 1997. It was attended by Alfred P. Rubin, the current President of the Branch, Cynthia Lichtenstein, past-President, and Professor Kenneth Gallant of the University of Idaho School of Law, who was in Europe to attend a meeting of an ILA Committee. The major items for discussion were the new Constitution for the ILA and the reconsideration of rules for membership in ILA Committees. The Constitutional amendments are technical and relate primarily to things necessary under British law to assure the continued tax exemption of the organization. The only item of significant interest to the American Branch is a new provision requiring vacancies in the offices of the Association to be notified to the Executive Council at least 90 days in advance of its next meeting, and nominations to fill those vacancies to be made (by any member of the Executive Council, including the three members from the American Branch) approximately 30 days before elections. A full reprinting of the new Constitution will be published in the ABILA Proceedings and in the Proceedings of the ILA next after its biennial meeting in Taiwan.

The ILA is preparing a "Home Page" for the world wide web.

A proposal was made for the ILA to establish at the Taipei Conference a "study group" on state responsibility to parallel the work of the International Law Commission. The study group is not to be a Committee of the Association, but an aid to the ILC. Nominations from the branches are invited.

The ILA is seriously considering establishing a new publication to consist of short "think-pieces" that stimulate discussion of international legal issues. Apparently something along the line of our own International Practitioner's Notebook in its original incarnation is envisaged: op.ed. pieces and letters to major newspapers would be circulated internationally. This publication would supplement the existing ILA Newsletter, which would continue to be circulated at no additional cost to all members. It was suggested that it be called something like "International Law Forum de Droit International;" the apparent redundancy would reflect the equality of English and French as the official languages of the ILA.

#### **ILA Committees**

New committee rules were approved. They will allow for more committee members from the larger branches of the Association. Under existing rules, only one member and one alternate member are allowed from each branch, although there are some historical remnants of a looser arrangement. Under the new rules, there would be one member in any committee allowed from any branch of the association; two members from branches with more than 150 members; and three members from branches with more than 250 members. The American Branch at this moment has 344 members, thus we would be entitled to three members in any ILA committee. As soon as the new rules are adopted by the Full Council in Taiwan, all our alternate members in ILA committees will be made full members.

There is yet another way to join an ILA committee. Under the newly approved rules, chairs of ILA committees may nominate up to three persons to membership in their committees regardless of branch affiliation. Each such nomination needs the approval of the Director of Studies. This procedure does not limit the existing authority of each branch to nominate members to places in ILA committees subject to the approval of the chair of the committee, but provides the chairs with an additional source of expertise in case more than one, two or three members of any particular branch have expertise believed important to the work of the ILA committee. Nor does the new procedure limit the existing arrangement whereby chairs and reporters' positions can be filled by the Director of Studies without regard to branch memberships.

Branch nominations: All ABILA nominations to international committees were approved and the current ILA committee memberships are noted in the list attached to this Newsletter.

### ILA Committee Membership Policy

Membership in international committees is based on individual reputation and achievement and does not represent any branch orthodoxy. Nominations by the American Branch to international committees are normally reserved to members of the branch who have achieved a reputation sufficient to support the nomination. Active work as reporter or chair of a branch committee is frequently the most persuasive criterion to establish a reputation adequate to support nomination to an international committee.

Several international committees do not have American Branch members or alternates. The easiest way to be nominated to membership in an international committee is to serve as an organizer/chairman or reporter of an American Branch committee dealing with a related subject.

If there is no international committee currently dealing with a significant topic of sufficient interest, the easiest way to form one is to organize an American Branch committee on that topic, produce a report that can be circulated to our counterparts in the parent organization, and then propose an international committee. The successful proposer of an international committee is usually asked to be its organizer, chair or reporter. The process is not difficult.

There is constant turnover in membership of both American Branch and ILA committees. Those members of the branch interested in participating more actively in the committee work of the organization at any level should contact the chairs of existing committees or the Director of Studies directly.

A full list of American Branch committees and their chairs, and of international committees and their American Branch members and alternates is included in this Newsletter.

# American Branch Committee Activities

Branch committee chairs are always looking for reporters and members who want to be active. A current listing of branch committees and their chairs and reporters is appended to this Newsletter. Any member of the branch wishing to organize a new branch committee on any topic within the purview of the ILA should contact the ABILA Director of Studies, Charles D. Siegal, Esq., proposing a topic, a reporter, and a plan for the recruitment of qualified members. The proposer may also take

the chair and serve as reporter for a new committee if a membership of the committee that is large enough and diverse enough can be achieved.
