INTERNATIONAL LAW WEEKEND

"The Challenge of September 11: International Law and The Control of Violence" is the theme of International Law Weekend, October 24-26, at the House of the Association of the Bar of the City of New York (42 West 44th Street).

The Weekend, which features 26 panels, will start at 4:30 p.m. on Thursday, October 24. As usual, the principal papers will be published in the International Practitioners Notebook, which will be distributed free of charge to all ABILA members. Dinner and luncheon talks will be published in the Proceedings of the American Branch.

Ambassador Richard S. Williamson, U.S. Representative to the United Nations for Special Political Affairs, will speak at the annual dinner on Friday, October 25, 2002. His theme will be "Transitional Justice." This special evening will begin with a reception at 6:30 p.m., followed by dinner, in the Princeton Club of New York at 15 West 43rd Street. The Honorable William Howard Taft IV, Legal Adviser to the Department of State, will address participants during the annual luncheon, Saturday, October 26, at the meeting venue. He will discuss significant implications today of terrorism and other forms of violence.

International Law Weekend is free to all ABILA members, students and members of co-sponsoring organizations. For others there is a fee of \$35. Preregistration is not required, but reservations for the annual dinner and luncheon must be made and paid for in advance. All members will receive details and a printed program within a few weeks. BOOK REVIEW

SCEPTICAL ESSAYS ON HUMAN RIGHTS. Edited by Tom Campbell, K.D. Ewing, and Adam Tomkins. Oxford: Oxford UP, 2001. xxxv, 423 pp. Soft cover.

By virtue of the (U.K.) Human Rights Act of 1998, Britain has incorporated most of the substantive provisions of the European Convention on Human Rights into its domestic law. One consequence is to shift primary responsibility for the articulation of these rights from the political processes of representative government to the judiciary. Essays presented here by twenty-one mostly British and Commonwealth scholars express reservations about the wisdom of what is viewed as a significant transformation in democratic governance.

The essays are grouped into three sections. The first deals directly with the reallocation of governmental prerogatives. A featured essay argues, for example, "that by reducing citizens to empty rights-holders we fail to give adequate weight in our polity to the democratic values of participation, engagement, transparency and belonging, alienating the governed and diluting the richness of the relationship between government and people to one of little more than plaintiff versus defendant" (Richard Bellamy, as paraphrased by co-editor Adam Tomkins at page 5). A related concern, one characteristic of traditional common law thinking, is that the statute is likely to permanently entrench what may turn out to have been merely transient trends in contemporary western constitutionalism.

A second section, directed more specifically than the others to lawyers and legal scholars, consists in case studies identifying areas of law -e.g., labor law, torts, criminal practice - as to which the Human Rights Act ironically may produce regressive tendencies. The final section offers case studies of another sort, seeking to draw lessons from experiences other democracies have had with judicial enforcement of human rights norms. Here the concerns are mostly with asymmetry among rights enumerated and omitted; undemocratic demographic patterns in national judiciaries; and whether, empirically, judicial institutions do a better job than political ones in promoting respect for human rights.

Mark Tushnet (Georgetown), the only American scholar represented in this collection, warns against exaggerating the extent to which our national experience can contribute to a general understanding of the justiciability of a bill of rights. Not only is our experience ambiguous, he writes, but it has evolved over two hundred years, and in an institutional framework unlikely to replicate itself readily elsewhere.

Judy Fudge (Osgoode Hall), the sole Canadian contributor, notes that when the Canadian Charter of Rights and Freedoms was adopted, in 1982, criticism of it was confined mostly to the left in law schools. Since then, she says, debate has become increasingly polarized, and dissatisfaction with its impact on Canadian political parties and constitutional arrangements has spread beyond academic journals and across the political spectrum. Professor Fudge looks at the types of rights claims asserted by progressive social movements, how the Supreme Court of Canada has dealt with these claims, and political reaction to its decisions. She uses decisions affecting freedom of expression to illustrate salient features of the dominant rights discourse.

Reviewers' platitudes aside, a brief comment or two may be of interest. First, as to the writing itself, full marks are due the co-editors, and OUP, for according a unity of style to writing that emanates, after all, from a variety of academic disciplines and individual tastes. The result is an elegance and continuity not often found in interdisciplinary collections. Second, impishly, I am drawn to the inference that this felicity may owe something to the fact that, so far as I can tell (with a little help from Google), none of the contributors identifies international law as his/her principal academic discipline.

ABILA WEB SITE

Known informally to recent generations of practitioners and scholars as the Whiteman Digest, the work has been recognized as one of the most important publications in the international law community. The *Digest* ceased annual publication in 1980 although some collective volumes covering the 1980s have been published.

The first volume in this new series covers the calendar year 2001 in 832 pages. The sales price is \$80. As in the past, each annual volume is prepared by the Office of the Legal Adviser of the Department of State and covers important developments in all areas of public and private international law. A volume covering 1989-1990 will also be published this year. Following that, the Legal Adviser's Office and the Institute will develop plans to cover the 1990s and future years.
