BICENTENNIAL CELEBRATION: PHILADELPHIA CONFERENCE, MARCH 25-26.

In cooperation with the American Bar Association and the American Society of International Law a two-day Bicentennial Conference on "The New Economic Interdependence — Legal and Policy Implications" will be conducted by the American Branch, I.L.A. at the University Hilton Hotel, Philadelphia, March 25-26, 1976. Panels will present and discuss materials on the overall world economic situation; the Charter of Economic Rights and Duties of States as seen by the developing and the industrialized countries; current views of the United States Government; and case studies of critical materials.

THE WORLD CONFERENCE, MADRID, AUGUST 29 - SEPTEMBER 4, 1976.

The Spanish Branch, I.L.A. has completed plans for the 57th world conference of the International Law Association to be held in Madrid, August 29, - September 4, 1976. Thomas Cook has been named official travel agent, and the American Branch has made arrangements with this firm for a series of tours prior to the conference for members wishing to attend. They will include hotel reservations in Madrid at a variety of hotels. Rooms will also be available in Madrid University dormitories, close to the meeting halls of the University where the sessions will be held. Buses will be provided to take members from hotels to the meetings. The subway also leads to the University gates, from which members may walk to the meetings or take a shuttle trolley car.

Registration forms, literature on the program and general tour information will be sent to members in the early weeks of 1976. American Branch members are automatically eligible for attendance, and they may also register spouses and offspring for the social events.

The provisional agenda for the conference includes: Water Resources; Air Law; International Terrorism; International Monetary Law; Law of the Sea; Space Law; International Medical and Humanitarian Law; Traffic Accidents (The Hague Convention); Human Rights; Landlocked States; International Arbitration; Environment; and a general discussion on the work of the I.L.A.

The conference is being conducted by the Spanish Branch, I.L.A., and is not a Spanish Government affair.

LIBRARIANS ASK "WHERE IS THE VOLUME ON THE 56TH I.L.A. CONFERENCE?"

At 4:00 P.M. the two panels will occur simultaneously, and they will be followed by the annual dinner at the Princeton Club. On

Saturday morning two new panels will sit, followed by a luncheon at the Association of the Bar and an afternoon session. A Hospitality Table will assist members and their spouses in arranging their New York activities.

WORLD ASSOCIATION OF LAW PROFESSORS

Academic members of the American Branch will be interested in the founding at the Biennial meeting of the World Peace Through Law Association in Washington on October 16, 1975 of a World Association of Law Professors within the World Peace Through Law Association. An international committee was elected to complete organization and prepare for a first meeting to be held in October 1977 in Berlin. Attention will be focused on legal education, with special concern for developing countries, and the basis for comment will be the reports on the subject prepared in 1975 by the International Legal Center in New York. Many members of the American Branch and the Association of American Law Schools are cooperating in organizing arrangements.
